A BILL

To amend the Elementary and Secondary Education Act of 1965 to improve mental health services for students, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expanding Student
5 Access to Mental Health Services Act”.

1 **SEC. 2. SUPPORTING MENTAL HEALTH.**

2 (a) STATE USE OF FUNDS.—Section 4104(b)(3)(B)
3 of the Elementary and Secondary Education Act of 1965
4 (20 U.S.C. 7114(b)(3)(B)) is amended—

5 (1) in clause (iii), by striking “and” at the end;

6 and

7 (2) by adding at the end the following:

8 “(v) improving the mental health serv-
9 ices available to students, which may in-
10 clude—

11 “(I) identifying and dissemi-
12 nating best practices for mental
13 health first aid;

14 “(II) assisting in the establish-
15 ment or implementation of emergency
16 planning, which may include emer-
17 gency response teams to address
18 emergencies at schools;

19 “(III) establishing or identifying
20 agreements with local health agencies,
21 including nonprofit, public, and pri-
22 vate mental health agencies and insti-
23 tutions, to improve coordination of
24 services; and

25 “(IV) telehealth services; and”.

1 (b) LOCAL EDUCATIONAL AGENCY APPLICATIONS.—
2 Section 4106(e)(1) of the Elementary and Secondary Edu-
3 cation Act of 1965 (20 U.S.C. 7116(e)(1)) is amended—

4 (1) in subparagraph (D), by striking “and” at
5 the end;

6 (2) by redesignating subparagraph (E) as sub-
7 paragraph (F); and

8 (3) by inserting after subparagraph (D), the
9 following:

10 “(E) if applicable, how funds will be used
11 for activities related to providing mental health
12 services under section 4108; and”.

13 (c) ACTIVITIES TO SUPPORT THE EFFECTIVE USE
14 OF TECHNOLOGY.—Section 4109 of the Elementary and
15 Secondary Education Act of 1965 (20 U.S.C. 7119) is
16 amended—

17 (1) in subsection (a)—

18 (A) in paragraph (5), by striking “and” at
19 the end;

20 (B) in paragraph (6), by striking the pe-
21 riod at the end and inserting “; and”; and

22 (C) by adding at the end the following:

23 “(7) providing technology to improve mental
24 health services.”; and

25 (2) in subsection (b)—

1 (A) by striking “A local” and inserting the
2 following:

3 “(1) IN GENERAL.—A local”; and

4 (B) by adding at the end the following:

5 “(2) EXCEPTION.—The limitation described in
6 paragraph (1) shall not apply to technology infra-
7 structure that is also used for mental health serv-
8 ices.”.
